An elementary school site visit is scheduled for Thursday June 20th starting @ 10:00am and shall be at Glenside Early Childhood Center 1213 W. Hackley Ave. Muskegon, MI 49441.

Each Proposal shall be accompanied by a certified check, cashiers' check, money order, or bid bond made payable to 0BThe Christman Company in an amount not less than five percent (5%) of the base bid as a bid security. The Bid Security of Bidders under consideration will be returned immediately after award of contracts by the Construction Manager. The amount of the guarantee shall be forfeited to the Owner if the successful Bidder fails to enter into a contract and furnish required bonds and insurance within 30 days after award of contracts.

Each Proposal shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Board or the Superintendent of the school district.
